The Village of North Barrington has again selected Constellation NewEnergy, Inc. ("Constellation") as the preferred supplier for its Municipal Aggregation Electricity Program. This includes a 12 month program that offers a fixed rate of 7.075¢/kWh for the term of July 2017 through July 2018 meter read cycles. The fixed price offered does not include taxes, ComEd distribution or other ComEd fees, charges or credits. As part of the renewal for this program, Constellation Energy Services, Inc. is assigning the North Barrington aggregation program to its affiliate, Constellation NewEnergy, Inc. Program participants will receive notices from ComEd alerting them of the change.

#### You're Automatically Enrolled
